Subject: Black Listing of M/s Diamond Shipping Company Limited.

M/s Diamond Shipping Company Limited who is having registered office at 33A J. L. Nehru Road, Kolkata, West Bengal – 700071 had been associated with PEC Ltd. as a Custom House Agent (CHA) as per Tripartite Agreement's Dated:24.11.2011, 30.01.2012 and 14.08.13. They have colluded with M/s Skyrise Overseas Pvt. Ltd. (Formerly known as M/s Saraf ImpexPvt. Ltd.) to part with the original shipping documents causing loss to the tune of Apprx Rs. 9.76 crore to PEC.

Further pursuant to direction of Second Level Committee of PEC Dated:02.02.2018, It has been decided to **blacklist/debar** M/s Diamond Shipping Company Limited as per circular no. 2/15 of PEC Dated:18.08.2015 which is available at PEC website (www.peclimited.com) and restrain them to make any further association with PEC for CHA , C&F , Vessel Agents and any other related jobs, Import, Export, Domestic trade with PEC & its office till clearance of the losses incurred by PEC Ltd. for a period of 3 years.

M/s Diamond Shipping Company Limited has been found to be guilty of impropriety & irregularity and has failed to meet contractual obligation, submission of original shipping documents to PEC Ltd. Therefore PEC has prohibited all its offices from entering into any further any transactions/association with the M/s Diamond Shipping Company Limited for a period of 3 years.
