2. UNDER CLAUSE No: B “LOCATIONS & QUANTITY” , & ANNEXURE-I “LOT-WISE & GRADE-WISE DETAILS OF RED SANDERS” & ANNEXURE-V (B) “PRICE BID” is amended to read as follows:

The LOT No.s:

- a) Under Sr. no. 1 for Location: Central Excise office, Pollachi may be read as **POL-1**.
- b) Under Sr. no. 1 for Location: M/s Gateway Distriparks CFS, Vallarpadam, Cochin, Container No. CRSU1378497 may be read as **COC-1**.
- c) Under Sr. no. 2 for Location: M/s Gateway Distriparks CFS, Vallarpadam, Cochin, Container No. YMLU8100268 may be read as **COC-2**.

3. UNDER CLAUSE No: G “EARNEST MONEY DEPOSIT (EMD)” Para 4 is amended to read as follows:

Bidder shall submit (separate BGs for the quantity at **Pollachi , Cochin, Kandla, Mundra, Chennai and Mumbai**) copy of the BG (EMD) with their techno-commercial bid and instruct their banker to forward the original BG directly to PEC New Delhi, so as to reach before the date/time of submission of bid.

4. UNDER CLAUSE No: U “ARBITRATION” amended to read as follows:

Any dispute or difference whatsoever arising between the parties out of or relating to the construction, meaning, scope, operation or effect of this Contract or the validity or the breach thereof shall be settled by arbitration in accordance with the Rules of Arbitration of the Delhi International Arbitration Centre (DAC), New Delhi and the Award made in pursuance thereof shall be binding on the parties. The venue for Arbitration shall be New Delhi the appropriate Courts in New Delhi shall have exclusive jurisdiction and Indian laws shall Govern this Contract.

5. Wherever “FOB” BASIS appears may be read as “FOB COCHIN/MUMBAI/KANDLA/MUNDRA/CHENNAI” in the tender from their respective location basis. For Pollachi Lot (POL-1), the buyers will be required to quote on FOB Cochin basis.

6. Amended “ANNEXURE –II: Declaration” is enclosed in Page -2 of this document.

7. UNDER ANNEXURE-VIII: “CHECK LIST OF DOCUMENTS TO BE ANNEXED TOWARDS SUBMISSION OF BIDS” UNDER “OTHER DOCUMENTS” may be amended to read as “TENDER DOCUMENT COST A DOCUMENTARY EVIDENCE FOR HAVING REMITTED COST OF TENDER DOCUMENT FOR Rs.10000/USD150” instead of existing.
